Potty and one handicap accessible Porta-Potty on site but if needed more than one could be brought in they will be concealed by a three-sided stockade style fence around the Porta-Potty area. Mark said he will be applying for an outdoor alcohol license to be used to sell alcohol by the shack area. There will be a fenced in area starting at the end of the shack and go around the area where the tables are with a maximum of 10 tables accommodating 60 people. He will be using LED Bistro style string lights shining downward in the shack opening.

After some discussion the board would like it to be noted that

1. The Shack will be open May through October
2. The hours will be Friday 4pm – 8pm, Saturday 11am – 8pm & Sunday 11am -5pm only (as written in the proposal dated 1/22/20)
3. The fence for the shack and signage would need to be back far enough from Rte. 55 so as not to impede sight lines for the exit from Schumway Rd.
4. No Parking on Rte. 55 or Schumway Rd.
