17.-1-22.1: James Donelli – Natural Subdivision located at 253 Pepacton Hollow Rd., Grahamsville, N.Y. Anthony Siciliano, Licensed Land Surveyor, was present representing the application. Phil Coombe read the code pertaining to a Natural Subdivision, stating the property size is exempt when separated by a public road. There is no provision specifying a size requirement for the remaining lots. There was a discussion concerning one of the lots being a ½ acre in size and both lots being substantially developed already. Ken Klein was in agreement there is no requirement for the lot size when separated by a public road. He also pointed out each piece is self-sufficient. Ken could not find a reason for the board to not approve the subdivision. No Public hearing is required.
