**SUPERVISOR**

The Town Board and guests who were present discussed the progress of the Route 42 Community Park. The following topics were discussed:

- **Infields**
  - TV Little League will clearly mark the infields of all fields for the placement of the red dirt. Highway will cut the sod out of the areas marked. TV Little League will provide the red dirt. The Town Board would like the red dirt to be available on the day the sod is cut out. All sod will be removed from the park to an alternate storage area. Supervisor Mathews will find out if there is an area in the park that a small amount of red dirt can be stored for field repairs.
  
- **Pavilion**
  - Jim Schmidt volunteered his time to do the electric. All materials necessary have been purchased by the Town for the installation of the electric.
  - Dave Trestyn has volunteered his time to do the plumbing. Materials have not been purchased yet.
  - Cathy Russo got a materials list for drywall in the pavilion. Electric and plumbing must be completed before any drywall can be done. Volunteers are ready to help for the drywall install.

- Insulating the walls was discussed. Tom Mitchell will contact Rich Kaveleski about spray foam insulation. This cannot be done until the electric and plumbing has been installed.
- The concrete floors should be treated with epoxy to protect them. TV Little League can do this. Tom Mitchell asked about using vinyl tile instead. Tom will get a price for tile.
- The Town Board asked AZ Lighting about donating LED fixtures for the building. Have not heard back from them.
  
- **Dug out pads**
  - The area for the dugout pads will be marked by TV Little League and should be cut out at the same time as the infield areas are. TV Little League is responsible for concrete forms and pouring. For the "Majors" fields Tom Mitchell would rather have dugouts that are down into the ground three feet and have block walls. The "Minors" fields will be at ground level. Tom will contact M&L Masonry to find out the difference in price for both styles. The construction of the dugout structures are also the responsibility of TV Little League.
  
- **Old garage**
  - The Board is in favor of demolishing the old garage due to its appearance. TV Little League would like to use it to store equipment. The Board agreed to allow it to stay if TV Little League will re-side the garage to match the pavilion and maintenance building and have the work completed by the Renaissance judging in early August.
  
- **Field maintenance**
  - The fields are being mowed. Weedwacking along the fences is also being done. TV Little League will continue to do the mowing and weedwacking.

**ADJOURN OR RECESS**

On motion by Councilman Keith Zanetti, seconded by Councilman Michael Mullen, put to a vote and UNANIMOUSLY CARRIED the meeting was adjourned at 9:42 pm.
