- 1. Highway Superintendent Preston Kelly updated the Board on **CHIPS** \$245,299.15, **PAVE NY** \$55,991.97 and **EWR** \$46,633.09 **funding**.
- 2. Highway Superintendent Preston Kelly requested permission to **attend** the **2021 Highway School** from June 7th to 9th, 2021.

3. Preston would like to **advertise** for **2 seasonal temporary workers**. The following motion was made:

A motion was made by Councilman Scott Grey, seconded by Councilwoman Nicole Gorr to authorize the advertising for two seasonal temporary workers in the Highway Department as laborers for the period between May $1^{\rm st}$ and September $30^{\rm th}$, with a minimum age requirement of 18 years old, at wage rate of \$15.00 per hour with no benefits, must have a valid driver's license, working 40 hours per week put to a vote and UNANIMOUSLY CARRIED.

4. Preston met with the Equipment Committee. Preston would like to replace two pickups this year because one was not done last year. There is no state bid for pickups but the Town can purchase through Statewide Piggyback on Onondaga County #ONGOV-106-19 for a Dodge 3500 with plow for \$40,845.70 each, \$81,691.40 for two. The following motion was made:

A motion was made by Councilman Scott Grey, seconded by Councilman Keith Zanetti to purchase two Dodge 3500 Pickups with plows for the total price of \$81,691.40 off Statewide Piggyback Onondaga County #ONGOV-106-19, put to a vote and UNANIMOUSLY CARRIED.

Preston also would like to **replace** the **John Deere Mower** off of **State Bid Contract** with a **John Deere 5075E Utility Tractor** \$37,827.55 with side mower \$35,742.75, rear finish mower \$5,305.91 and PTO leaf & debris blower \$6,700.06 for a total of \$85,576.21. The old mower would either be traded in or sold on Auctions International. The following motion was made:

A motion was made by Councilman Richard Coombe Jr., seconded by Councilman Keith Zanetti to purchase a John Deere 5075E Utility Tractor with attachments for a total of \$85,576.21 off State Bid Contract, put to a vote and UNANIMOUSLY CARRIED. VOTE: AYES 5 NAYS 0.

5. Preston and the Board discussed the **replacement** of **4-wheel drive plow trucks**, Freightliner vs Oshkosh. The price difference is roughly \$109,000 but the longevity of the Oshkosh is 25+ years, compared with the Freightliner that is 15 years. The Board is leaning more towards the Oshkosh. Preston is going to get more information on the Oshkosh truck.
