2. Preston would like to go to bid for diesel fuel, heating fuel for both the Town Barns and Town Hall, gasoline, ice control sand, fine dry screenings, stone and crusher run.

A motion was made by Councilman Richard Coombe Jr., seconded by Councilman Keith Zanetti to authorize the Town Clerk to advertise a request for bids for diesel fuel, heating fuel for both the Town Barns and Town Hall, gasoline, ice control sand, fine dry screenings, stone and crusher run. Bids will be required to be back in the hands of the Town Clerk by 2:00 pm on Friday, May 3, 2019. The Town Board reserves the right to reject any and all bids, put to a vote and UNANIMOUSLY CARRIED.

- 3. The covered **bridge** into the **fairgrounds** was **red flagged** by the County due to rust on the girders. Preston is working with the County on plans to repair the girders. In the past similar repairs were made. Preston would like to re-plate all of the girders at the same time, not just the ones that were flagged. The Highway Department will do the repairs.
- 4. Preston received notification that the Governor **cut extreme weather recovery money** out of the State Budget. This will amount to **\$46,633.09** that Preston will **lose** for **blacktopping** this year.
- 5. Preston met with the Equipment Committee and it was decided to **replace** the **small** 2007 Komatsu PC-78us-6 **excavator**, Helac power tilt head, manual thumb and 36" and 24" ditching bucket excavator with a new Caterpillar 308e2 excavator with hydraulic thumb, power tilt head with 30" digging bucket and 48" ditching bucket from State Contract. The cost is \$115,000.00 with the funds to come from highway unexpended fund balance. Preston would also like to put the old excavator out to bid on Auctions International. The following motion was made:

A motion was made by Councilman Scott Grey, seconded by Councilman Keith Zanetti to purchase a 2019 Caterpillar Excavator with attachments from State Contract with the amount not to exceed \$115,000.00, funds to come from highway unexpended fund balance and to also put the old Komatsu excavator with attachments out to bid on Auctions International, put to a vote and UNANIMOUSLY CARRIED.

- 7. Supervisor Mathew's spoke to the Board concerning **trees** that need to be **cut** in the older **cemeteries** in the Town.
