Jamie Dymond Brooks, Parks and Recreation Director, gave a Parks and Recreation update on upcoming and completed events. Jamie would like to use the new tent for screen free week. The Board asked her to coordinate her using it with Joe Bagley. Jamie also updated the Board on looking into using the community garden by the Claryville Reformed Church. It has not been used for the last few years and those who used it stopped because of the lack of individuals who would commit to weeding and the other work that is necessary to have a vegetable garden.

Mark McLewin, Neversink General Store, is beginning the third year of his temporary use permit for the Farmer's Market. Mark would like to make a few changes in the layout of the market. He distributed drawings showing the new set up he is proposing. The time of operation has also been changed from 10-2 to 11-3. The following motion was made:

A motion was made by Councilman Richard Coombe Jr., seconded by Councilman Keith Zanetti to grant the Temporary Use Permit for the Farmer's Market with the changes suggested. The Town Board is suggesting that Mr. McLewin start the process with the Planning Board for a special use permit, put to a vote and UNANIMOUSLY CARRIED. VOTE: AYES 5 NAYS 0.

Route 42 Community Park update. Topics discussed were the status of the fencing, possible purchase of replacement mowers and the installation of electric for the score boards. Tri-Valley School requested use of the big field on April 21st for a baseball tournament through Little League. The Park

Officer did received a certificate of liability insurance from the school but not a completed park use form. The Board was concerned that the fences would not be up in time for the tournament. The Park Officer has updated the Fairgrounds Park/Pavilion Use Form and created a Route 42 Community Park/Pavilion Use Form. Cathy Russo will reach out to the School and let them know that there is a Park Use Form available for both locations. The forms will be put up on the Town's website for those that wish to use the Parks. Forms can also be picked up in the Town Clerk's office during normal business hours.

Highway Superintendent Preston Kelly and the Board discussed work that still needed to be completed at the Park. He has a **punch list** of items that need doing. The parking lots need to be stripped. This is help people to park correctly and the number of cars that can park will increase. Exercise stations were received through a Plans and Progress Grant and have been delivered. Preston is going to try and get them installed before the grand opening on May 19th.

The Route 42 Community Park **Grand Opening** celebration is scheduled for **May 19th at 11:00 am**. Refreshments will be served.

Chris would also like to pursue a Plans and Progress Grant for an enclosed **dog park**. It would be built in the lower area of the Park towards Town, below the walking path.

• **Brent Gotsch, ZBA** Chairman, filled the Town Board in on the business that was before the ZBA at their last meeting. Brent did training at the Town Hall on March 24th for Planning Board and ZBA members.

HIGHWAY SUPERINTENDENT

1. Highway Superintendent Preston Kelly would like to go to bid for diesel fuel, heating fuel for both the Town Barns and Town Hall, gasoline, ice control sand, fine dry screenings, stone and crusher run.

A motion was made by Councilman Keith Zanetti, seconded by Councilman Michael Brooks to authorize the Town Clerk to advertise a request for bids for diesel fuel, heating fuel for both the Town Barns and Town Hall, gasoline, ice control sand, fine dry screenings, stone and crusher run. Bids will be required to be back in the hands of the Town Clerk by 2:00 pm on Monday, May 7, 2018. The Town Board reserves the right to reject any and all bids, put to a vote and UNANIMOUSLY CARRIED.

- 2. Preston spoke about problems with the **County Snow removal contract**. Many neighboring Towns have told the County they are not going to plow for them anymore. Preston is proposing that the Town Board write a letter to the County and point out some problems areas that exist with the roads that the Town plows for the County. The Town of Neversink plows about 15.21 miles of County Roads under the contract. The roads are CR 153 (Sundown Rd.), CR 19 (Claryville Rd.) and CR 156 (South Hill Rd.) and CR 17, the County's portion of Route 55. Preston will work on a letter with Supervisor Mathews to send to the County. He is not saying he does not want to plow it, he would just like to see some repairs made to certain roads that would make them safer to plow.
- 3. Preston is looking for the maintenance agreement for the Halls Mills Covered Bridge.
- 4. The following is the NYS DOT FIGURES FOR 2018-2019. An increase of \$1,287.01 over last year.
 - a. CHIPS \$246,189.09
 - b. PAVE NY \$56,191.49
 - c. Extreme Winter Recovery (added funding for this year) \$46,633.09 Total - \$349,013.67
- 5. The new **Transfer Station sign** was delivered.
- 6. The new **pickup on order off of State Bid** is currently backordered. Preston spoke to Robert Green in Monticello and they currently have a truck that is almost the same specs as the one on backorder. It has two additional options that the State Bid truck does not have. Robert Green is willing to sell the truck to the town for the State Bid price.
