- 10. Chairman of the County Legislature, **Luis Alvarez**, is scheduled to come to our August 9<sup>th</sup> Meeting to speak about what is going on in the County. The Board discussed possibly having a special meeting before that date.
- 11. Supervisor Mathews and Councilman Brooks met with **Spectrum** to talk about cable service in the Town of Neversink. Councilman Brooks also met with the Robert and Daniel McGuigan about fixed wireless.

Councilman Richard Coombe Jr. requested that the record show that it would be the Board's preference to hire the individual that lives in the Town of Neversink but that person they believe has a conflict of interest given that part of the job involves Parks and the Parks Officer is that person's spouse. As a result the personnel committee would recommend that the Town hires Joe Bagley.

A motion was made by Councilman Keith Zanetti, seconded by Councilman Scott Grey to appoint Joe Bagley to the position of maintenance person, put to a vote and UNANIMOUSLY CARRIED.
