Twenty residents of the Claryville area were present tonight with concerns about the **Neversink River Public Fishing Access Site**. Tom Matthews and others spoke about traffic problems, loud music, garbage, illegal parking, camping, campfires and more. Under Sheriff Eric Chaboty addressed the illegal parking problem. The Sheriff's department has been writing tickets to those cars parked where the no parking signs are posted. A few cars have even been towed. The Sheriff's Department will respond to calls that indicate there are illegally parked vehicles. Forest Ranger Howard Kreft also addressed the group to explain what can and cannot be done as it is public land and open to all for recreational use. A Resolution was previously passed by the Town of Neversink in August of 2020 that will provide for more regulations to be put into place similar to the Blue Hole. Ranger Kreft will be

working on getting more regulations in place that would restrict many of the issues that are being troublesome to local residents.

Cher Woehl, Parks and Recreation Director, asked the Board for approval of the Memo of Understanding that was drawn up with the Rondout Stream Program for any programs that are being done jointly with them, such as the kayaking event. Town Attorney Ken Klein has reviewed it and finds it acceptable. The Board approved the document. Cher filled the Board in on the upcoming kayaking event.

Cher is working at plans to show **movies** at the **fairgrounds** as a Parks and Recreation event. Tri-Valley School has graciously added the Town of Neversink onto its Movie License. Cher has been pricing inflatable movie screens and projectors. It was suggested by the Board that Cher look into purchasing a larger screen than she mentioned looking at. TOWN OF NEVERSINK RESOLUTION NO. 16 of 2021 RESOLUTION ADOPTING REVISIONS TO HEALTH INSURANCE POLICIES

The following resolution was introduced by Councilman Keith Zanetti, who moved for its adoption, and seconded by Councilwoman Nicole Gorr, to wit:

WHEREAS, the Town of Neversink ("Town") offers health insurance benefits to eligible Civil Service Employees, Appointed Employees, and Elected Officials in accordance with New York State Law; and

WHEREAS, the Town maintains policies regarding such benefits, and such policies were adopted by motion of the Town Board on November 14, 2018; and

WHEREAS, to clarify said policies, the Town sought to make certain revisions thereto; and

WHEREAS, such clarifying revisions were approved the New York State Department of Civil Service; now, therefore,

BE IT RESOLVED, the Town's health insurance policies shall be modified as reflected in the attached.
