The purpose of the meeting tonight was to discuss the potential Watershed Hamlet Extensions. Tim Cox, Catskill Watershed Corporation Council, was present via ZOOM. Mr. Cox gave an overview of what events lead up to the 1997 Watershed Memorandum of Agreement (MOA) which provides a mechanism which allows municipalities to limit the City's ability to purchase land and conservation easements in order to ensure that each community had adequate developable property to adapt to a changing climate and economy. A town can prohibit the City from acquiring certain parcels in fee simple in certain designated areas. Additionally, a town or village could, by resolution, expand the lands subject to acquisition by waiving certain minimum acreage requirement, allowing the City to purchase lands regardless of the lot size. The agreement restricts the City's power to buy land for the next five years. Between December 24, 2020 and June 21, 2021 ("2021 Determination Period"), municipalities may again, by resolution, reassess their prior resolution and make any changes allowed under the agreement. Mr. Cox reviewed and explained what changes can be made. During this period, municipalities can do nothing and lets the prior resolution(s) stand or they can pass new resolutions changing the prior determinations. Whatever is done it is good for the next five years and no changes can be made after June 21, 2021. Tim answered any questions from those either present in person or via ZOOM.

SUPERVISOR:

1. The Board discussed the information from Tim in relationship to whether they want to make any changes to what is currently in effect and agreed to revisit it at the regular May meeting.
