Phil Coombe III, began the meeting, and then turned it over to Anthony Siciliano, LS, PC. Referring to the map, Anthony pointed out and explained the details and layout of the proposed Lot Improvement. The Aveners are deeding 1.20 acres of their 4.21 acre parcel to the Blaunsteins 2.81 acre parcel. This would leave the Aveners with 3.01 acres, and the Blaunsteins with 4.01 acres. There is a shared driveway, which is an existing condition that will not be changed.
